Tenders not accompanied by EMD shall be summarily rejected. National Board of Accreditation shall not be liable to pay and refund any interest earned, if any, on the earnest money.
2. Applications received after the stipulated date and time shall not be accepted. NBA shall not be responsible for any Postal delay.
3. Incomplete and conditional application shall be summarily rejected.
4. All the copies of documents attached must be attested by Authorized Signatory under the Company Seal.
5. NBA reserves the right not to assign reasons for declining to consider any particular application or applications. NBA also reserves the right to accept or reject any application or all applications.
6. Copies of PAN Allotment and Income Tax Returns filed for the last 3 years i.e. 2011-2012, 2012-13 & 2013-14 and Service Tax Registration Certificate along with Service Tax Registration Number will have to be attached with the application.
7. Copy of the Memorandum of Articles of Association/Partnership Deed/Proprietorship Deed/Certificate of Incorporation (In case of company) etc. attested by Chartered Accountant should be attached with the application.
8. The successful applicant (s) will have to execute an agreement on non-judicial stamp paper worth Rs.100/- and attested by a Notary Public/Oath Commissioner/First Class Magistrate. The cost of the stamp duties for the execution of the agreement shall be borne by the Service Provider.
9. The duration of the empanelment shall be for a period of one year, extendable by another year at the discretion of NBA, depending upon the quality of service provided, from the date of issue of the letter of empanelment.
10. The NBA reserves the right to terminate the panel/empanelment of any of the empanelled Service Providers/all the Service Providers empanelled at any time before the expiry of the empanelment period without assigning any reason by giving one month's notice.
