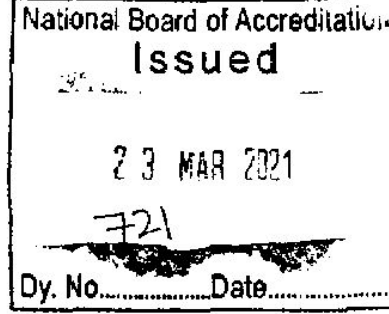

As per NBA norms the programs which have continuous approval of 5 or more years from the regulatory organisations such as AICTE, Affiliating University, PCI, State Board of Technical Education (Diploma) etc. and of which at least two batches have been passed out are considered for accreditation. No such circular was received by this Public Authority from UGC.
